Re: <u>Cboe Digital Exchange, LLC Rule Certification</u> <u>Submission Number CDE-2025-03</u>

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and Regulation 40.6(a) of the regulations promulgated by the Commodity Futures Trading Commission ("CFTC" or "Commission") under the Act, Cboe Digital Exchange, LLC ("CDE" or "Exchange") hereby notifies the Commission of the delisting of certain financially-settled Bitcoin futures ("FBT") and financially-settled Ether futures ("FET") contract expirations, effective the close of business on June 6, 2025. As described below, following the close of business on June 6, 2025, there will be no open interest in FBT and FET futures contracts on CDE.

As further described in CDE Rule Certification Submission Number CDE-2024-15E submitted to the Commission on December 19, 2024: FBT and FET futures are planned to be delisted from CDE after the close of trading on the June 6, 2025 trade date and to be transferred to Cboe Futures Exchange, LLC ("CFE") commencing on the June 9, 2025 trade date. More specifically, after the close of trading on June 6, and prior to the opening of trading on CFE for trade date June 9, all open interest in FBT and FET futures positions on CDE will be transferred into equivalent positions in FBT and FET futures on CFE.

As a result, the following FET and FBT futures contract expirations will not have open interest following the close of trading on June 6, 2025 and will be delisted from CDE:

- FBTM25 futures contract expiring on June 27, 2025; and
- FETM25 futures contract expiring on June 27, 2025.

Core Principle Compliance

CDE believes that delisting these products is consistent with Designated Contract Market Core Principle 7 (Availability of General Information) under Section 5 of the Act because, following the close of business on June 6, 2025, all open interest in FBT and FET futures positions on CDE will be transferred into equivalent positions in FBT and FET futures on CFE. CDE will update the list of instruments currently listed for trading on CDE that it makes available through its daily futures instrument file, market data, and website to no longer include FET and FBT futures contracts as instruments listed for trading on CDE.
